

### **Community and Economic Development**

2020 was another successful year for the Community and Economic Development Division. In all, NWAEDD was responsible for writing and administering approximately \$8.7 million in grant awards throughout the region. 2020 was a very challenging year as travel was curtailed due to the COVID-19 pandemic, but we adjusted and continued to work on behalf of our cities and counties. It is our pleasure to serve each of our member communities and it is the relationships with the people involved that make sharing these success stories such a pleasure. The following paragraphs detail some of our successes.

NWAEDD continued its strong partnership with the Economic Development Administration in 2020 through two major grant awards for the cities of Springdale and Fayetteville. Springdale was awarded \$1.5 million for its Kendrick Avenue improvement project that will enable a new manufacturer to locate to the area and add 65 new jobs. Fayetteville received a \$2 million grant for infrastructure improvements in its Commerce District to extend Borick Drive which will open the last piece of available land for manufacturers to locate there.

2020 was a very active year working with our counterparts at the Arkansas Economic Development Commission (AEDC) through the efforts of Catherine Baker, the District's Community Development Block Grant (CDBG) coordinator. In total, NWAEDD communities received just north of \$4 million through the CDBG program. The City of Flippin was awarded \$1 million for drainage wastewater improvements and Briarcliff was approved for \$1 million for a water expansion. Mountain Home received a \$200,000.00 CDBG investment to renovate a facility purchased by the children's advocacy group, Grandma's House, and Carroll County received a \$198,265.00 to remodel its health unit. Also, in response to the COVID-19 pandemic, AEDC invested heavily in rural hospitals. NWAEDD administered \$1.75 million in special CDBG awards for North Arkansas Regional Medical Center in Harrison, Baxter Regional Medical Center in Mountain Home, Siloam Springs Regional Hospital, and Ozarks Community Hospital in Gravette. The staff responded quickly and efficiently to assemble the hospital applications to enable them to access these muchneeded funds.





NWAEDD also remained active with AEDC's Rural Services Division by partnering for \$191,457.13 in grant awards. Grantees included the communities of Oak Grove, Gilbert, Hindsville, Elkins, Bergman, and Kingston. These grants helped renovate community centers, purchase firefighting equipment, and make various other improvements.

Tina Cole, Community & Economic Development Coordinator, continued her strong efforts in promoting the programs offered through FEMA. Tina worked with Baxter County to secure a \$900,000.00 grant for improvements to Denton Ferry Road, along with a \$40,000.00 grant for Baxter County to update its Hazard Mitigation Plan.

Through an EDA grant made possible by the CARES Act NWAEDD hired its first Disaster Recovery Coordinator/Communications Specialist. Chelsey Weaver joined our team in August of 2020 and has done an amazing job leading our efforts in recovering from the Coronavirus. Chelsey also was tasked with leading the District's charge in ramping up its social media presence. Again, we love working for our members and hope to continue to build on these successes and further strengthen our communities in 2021!





#### **WIOA Partner Meetings**

Quarterly meetings are held with all Core 4 Partners at different locations throughout the district. This Business Services Training Workshop was held in Harrison on January 29, 2020. The purpose of the meeting was to form business services teams in the Fayetteville/Rogers, Harrison and Mountain Home areas and to discuss sector strategies. Thirty-one people attended with representatives from DWS, NWAEDD, Arkansas Rehabilitation Services (ARS), Services for the Blind, Northwest Technical Institute (NWTI), North Arkansas College, Arkansas State University at Mountain Home (ASUMH), Ozark Literacy Council, Goodwill and the NCBA Older Worker Program.

#### NWAEDD Participated in the TANF Non-Recurrent Short-Term Benefits (NRSB) Program

This special initiative was open to UI Claimants who were:

- Eligible for state or federal unemployment benefits, had a weekly benefit amount of less than \$100, AND had a demonstrated need for assistance. Need for assistance may be demonstrated by any of the following:
- ♦ The participant was unable to work due to contracting COVID-19 leading to lost wages
- Children's school or childcare provider closed due to COVID-19
- ♦ Workplace closed due to COVID-19
- Rent or mortgage assistance due to COVID-19
- ♦ Utility assistance due to COVID-19
- Lost housing due to COVID-19
- Similar circumstances that were not COVID-19 related, that demonstrated a specific crisis situation or episode of need
- ♦ Unemployed or partially unemployed due to disruptions caused by the COVID-19 pandemic
- ♦ Family income was less than 200% FPL
- ♦ Custodial parents with a child under the age of 18 or a woman who was currently pregnant.

This assistance was available in addition to any employment benefits individuals in the family may be receiving.

Qualifying families received a payment of \$300 per week for a total of eight weeks.

#### **North Arkansas College Adult Education Program**

Betty Krumwiede graduated from the Northark Adult Education program with her GED in 2019. She was recognized as an outstanding student for her high score in the Math and Reading Language Arts portions of the GED exam. She began working for Northark Adult Education as an Administrative Assistant in August of 2020. She enrolled in the Northark Adult Education program because she recognized the need to complete her GED so she could begin college courses. Her GED instructor Chris Adams, had this to say "Betty came into the GED program with a strong work ethic and a positive attitude. I knew Betty would progress through the GED program and would be successful in life. Anyone that will work hard and keep a positive attitude can accomplish just about anything they decide to do. Betty is a great example of



how to approach an education and life in general." Northark Adult Education is fortunate to have her working with us; she understands what it is like to be a student in Adult Education, therefore she truly relates to everyone who walks through our doors. She is very energetic and brings positivity to our office atmosphere. She said she likes working at Northark Adult Education because she "is able to help other people succeed". Betty is the perfect example of what can be accomplished if you try hard and set your mind to achieving your goals.

#### Michael Salentine, Former NEG Participant

Michael Salentine. pictured in the back row (fourth from the left) was a participant on the National Emergency Grant (NEG) program for the City of Bull Shoals from November 2017 to November 2018. He was able to continue working there after the program ended and now assists with operation of the





### **North Arkansas Transportation Services**

NATS is the public transportation division of Northwest Arkansas Economic Development District. NATS has both interstate and intrastate route authority and serves the counties of Baxter, Boone, Carroll, Fulton, Izard, Madison, Marion, Newton, and Searcy Counties.

During 2020 the value of the service we provide to Northwest Arkansas was made more apparent than ever. Having affordable and reliable public transportation services in the community is often taken for granted, but the circumstances of last year highlighted the important role that NATS plays in the

everyday lives of residents throughout the counties we serve.

NATS implemented new health and safety protocols at the beginning stages of the COVID-19 emergency. On March 16, 2020 NATS suspended the city routes in both Harrison and Mountain Home to limit public exposure. We were able to continue to provide the demand response service. NATS has kept this system in place since that time. Throughout the year, NATS followed CDC guidelines as well as state and federal directives. In addition to the requirement to wear face masks, we had plexiglass installed to go between the driver and passengers in the vehicles and practiced social distancing, wore gloves, and completed thorough disinfectant procedures.



Despite the difficult circumstances and changes in procedures, NATS fleet of 59 vehicles traveled a total of 565,418 miles during 2020. Regardless of all the challenges that had to be overcome, the NATS team worked hard to provide a critical public service.


