It is approximately \$1.3 million, and all eight development districts will be participating in this effort. He also mentioned that with the passage of the new Federal Infrastructure bill that there is some funding to assist local jurisdictions with bridge repair and replacement. The district is working with the AAC to determine a path forward to access some of that funding. Additionally, he noted that the district has six EDA projects in process – Berryville, Fayetteville, two in Harrison and two in Springdale. These represent the most ever at one time for the district and are indicative of the relationship between it and EDA, thereby providing enormous resources to these areas.
